

Privacy Policy of Boomconsole

This Privacy Policy governs the collection, use, and disclosure of information by Boomconsole and its affiliates (“**Boom Console**”, “**we**”, “**our**”, or “**us**”) in relation to the use of our websites, services, and applications (referred to collectively as the “**Services**”). We may collect and receive information about individuals who use our Services (“**users**”, “**you**”, or “**your**”) from various sources. This policy applies to all users who utilize our Services.

Please read this privacy policy carefully as it will help you make informed decisions about sharing your personal information with us.

I. INFORMATIONS WE COLLECT

1.Information You Provide

1.1 Registration

When you visit the Site, to become a subscriber to the Service you will need to create a personal profile. You can create a profile by registering with the Service and entering your name, email address, and creating a user name and a password. By registering, you are authorizing us to collect, store and use your email address in accordance with this Privacy Policy.

1.2 Payment Information

When you add your financial account information to your Account, that information is directed to our third-party payment processor. We do not store your financial account information on our systems; however, we have access to, and may retain, subscriber information through our third-party payment processor.

1.3 Communications.

If you contact us directly, we may record and collect the additional information about you while communicating such as phone number, the contents of the message, and any other information you may choose to provide.

2. Information collected via Technology

2.1 Cookies and Other Technologies

Like any other chrome extension, Boom console also collects information provided to us by your browser or by our software application when you view or use the Service, such as URL, the type of browser you use, the device from which you connected to the Service, referring/exit pages and the time and date of access, and other information that does not personally identify you.

2.2 Usage of our Services

When you use our Services, we may collect information about your engagement with our Services, such as processor and memory usage, storage capacity, navigation of our Services, and system-level metrics.

II. HOW DO WE USE AND SHARE INFORMATION

We use the information we collect in various ways, including to:

- To fulfill and manage your orders. We may use your information to fulfill and manage your orders, payments, returns, and exchanges made through the Services.
- To respond to user inquiries/offer support to users. We may use your information to respond to your inquiries and solve any potential issues you might have with the use of our Services.
- To send you marketing and promotional communications. We and/or our marketing partners may use the personal information you send to us for our marketing purposes if this is in accordance with your marketing preferences. You can opt out of our marketing emails at any time

- Analyze and survey on the quality of our Services. We may use your information to develop aggregate analysis and business intelligence that enable us to operate, find and prevent fraud, take action, and to report on the performance of our business.
- Communications. We may use our information to communicate with you, either directly or through one of our partners, including for customer service, to provide you with updates and other information relating to the Service, and for marketing and promotional purposes

III. HOW WE SHARE INFORMATION

Boom Console does not store your scraped data, images, chats, urls you go through using Boom Console, Chrome Extension in any way. and We may not use or disclose the information provided by you except under the following circumstances:

- As necessary to provide services or products you have ordered;
- In other ways described in this Policy or to which you have otherwise consented;
- In the aggregate with other information in such a way so that your identity cannot reasonably be determined;
- As required by law, or in response to a subpoena or search warrant;
- To outside auditors who have agreed to keep the information confidential as necessary to enforce the Terms of Service;

IV. HOW LONG DO WE KEEP YOUR INFORMATION?

The data we collect from you will be stored for no longer than necessary. The length of time we retain said information will be determined based upon the following criteria: i) The length of time your personal information remains relevant; ii) the length of time it is reasonable to keep records to demonstrate that we have fulfilled our duties and obligations; iii) any limitation periods within which claims might be made; iv) any retention periods prescribed by law or recommended by regulators, professional bodies or associations; v) the type of contract we have with you, the existence of your consent, and our legitimate interest in keeping such information as stated in this Policy.

V. DATA STORAGE AND SECURITY

1. Data Storage:

Boom Console stores the collected data in a secure and encrypted freeSchema database. The data is stored for the purpose of user reference and retrieval.

2. Data Security:

Boom Console takes reasonable measures to protect user data from unauthorized access, loss, or alteration. However, no method of data transmission or storage can guarantee complete security. Users acknowledge and accept these inherent security risks.

We use Secure Socket Layer (SSL) for authentication and private communications to build users' trust and confidence in the internet and website use by providing simple and secure access and communication of credit card and personal information.

IV. CHOICE OF USING INFORMATIONS (UNSUBSCRIBE OR OPT-OUT)

All users and visitors to our website have the option to discontinue receiving communications from us by way of email or newsletters. To discontinue or unsubscribe from our website please send an email that you wish to unsubscribe to privacy@boomconsole.com. If you wish to unsubscribe or opt-out from any third-party websites, you must go to that specific website to unsubscribe or opt-out.

V. DATA PROTECTION RIGHTS UNDER THE GENERAL DATA PROTECTION REGULATION (GDPR)
